# <u>First Amendment to Construction Contract</u> (Lagoon Conversion to Stormwater Quality Pond and Demolition of the South Water Reclamation Facility Improvements P21-638)

This First Amendment to Construction Contract (the "First Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 2023 (the "Effective Date"), by and between the Town of Erie, a Colorado municipal corporation with an address of 645 Holbrook Street, P.O. Box 750, Erie, CO 80516 (the "Town"), and L4 Construction LLC, a Colorado limited liability company, with a principal place of business at 2350 17<sup>th</sup> Ave. #204, Longmont, CO 80503 ("Contractor") (each a "Party" and collectively the "Parties").

Whereas, on January 17, 2023, the Parties entered into a Construction Contract (the "Contract");

Whereas, the Parties wish to amend the Contract as set forth herein.

Now Therefore, for the consideration hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. <u>Scope of Work</u>. The Contract is hereby amended to include the following additional items in the Scope of Work:

- A. Demolition of additional concrete rings around the clarifiers;
- B. Abandon two existing sewer lines;
- C. Pump out wet well; and
- D. Tap domestic main for new irrigation connection.

2. <u>Compensation</u>. The Contract is hereby amended to increase the maximum amount of compensation to \$4,557,390, allocated as follows:

First Amendment:	\$	57,000
Total New Contract Amount	\$4,557,390	

3. <u>Term</u>. The term of the Contract is hereby extended through June 15, 2024.

4. <u>Remainder of Contract</u>. Except as expressly modified herein, the Contract shall remain in full force and effect.

# ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Town of Erie (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
