Third Amendment to Agreement for Professional Services

This Third Amendment to Agreement for Professional Services (the "Third Amendment") is made and entered into this ____ day of _____, 2023 (the "Effective Date"), by and between the Town of Erie, a Colorado municipal corporation with an address of 645 Holbrook Street, P.O. Box 750, Erie, CO 80516 (the "Town"), and RockSol Consulting Group, Inc., an independent contractor with a principal place of business at 12076 Grant Street, Thornton, CO 80214 ("Contractor") (each a "Party" and collectively the "Parties").

Whereas, on May 13, 2022, the Parties entered into an Agreement for Professional Services (the "Agreement");

Whereas, on March 1, 2023, the Parties amended the Agreement to add additional services and change the amount of compensation (the "First Amendment");

Whereas, on March 28, 2023, the Parties amended the Agreement to add additional services and change the amount of compensation (the "Second Amendment"); and

Whereas, the Parties wish to amend the Agreement again as set forth herein.

Now Therefore, for the consideration hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. <u>Scope of Work</u>. Exhibit A to the Agreement is hereby amended by the inclusion of the following additional items in the Scope of Work.

Contractor shall provide:

- a. Additional Hydraulic Modeling of the box culvert channel and Historic Clearance Services for the Sullivan Ditch and adjacent property at the southwest corner of the project as required by CDOT; as described in Contractor's proposal dated October 27, 2023; and
- b. Post-Design Services including:
 - RFI Review and Response
 - Submittals Review and Response
 - Support for design updates/changes
 - As-built drawings

All as described in Contractor's proposal dated October 31, 2023.

2. <u>Compensation</u>. Exhibit B to the Agreement is hereby amended to increase the maximum amount of compensation to \$191,608, allocated as follows
