Why are you interested in serving on a board or commission and what specific talents or expertise do you bring if appointed?

I am a resident of the Erie Airpark and an airplane owner. I feel it is important that the airpark community has a voice in the future of the Airport. As with most residents of the Airpark, I have a passion for aviation and want this airport to thrive. It is a special facility that not all municipalities have, and we need to make it the best resource for the community along with being a good neighbor.

Have you served on another board/commission in an advisory capacity? If so, please describe the board and what made serving in that capacity a good experience? What were the major concerns or issues?

Not directly. However I was a Vice President of a commercial construction company during my working career, on very large projects that often had a Dispute Resolution Board which I was a member of. The DRB was tasked with settling project issues at the project level before they escalated to litigation. Disputed issues were often complex, with large financial impacts. It required me to look at both sides of a dispute, evaluate culpability, if any, and reach fair and equitable solutions for all parties involved. Emotions can run high in these situations, and it taught me how to not escalate those emotions and not get entrenched in one position.

Please describe a situation where you were working with a small group and disagreed with the direction of the project, what did you do? What was the result?

In my position as Vice President of a construction firm, I often had situations where viewpoints differed between Owner, Architect, and Contractor (and subcontractors). Without getting into specifics on any particular issue, the thing I learned is I was one voice in the conversation. If I felt strongly about an issue, I was most successful when I would articulate my position without emotion and based on facts and not conjecture. I believe this approach gave me credence with my peers and most often led to positive results.

If you were appointed, what goals would you like to see accomplished on this board or commission?

The aviation community is facing some hurdles. We have the issue of leaded fuel creating concern with the local community. Noise pollution is a big issue given the residential growth around the airport. Keeping the airport a financially viable asset to the City, while being the best neighbor we can be. These would be my goals if I were appointed to the Advisory Board.

I am retired and would make the personal time for the Advisory Board a priority.
