## Highlights of the Expenditures:

- Management costs: \$670,662, combining the URA Attorney, URA Direct Costs and the Indirect Cost Allocation. These equate to 7.8% of the total URA Fund budget of \$8.635 million. The URA Attorney costs ensure the Town has a dedicated attorney for these types of questions.
  - The URA Direct costs include the new URA accountant/analyst as well as 25% of the salary costs of the Economic Development Director and the Town Administrator. The balance of the direct

- costs include: travel, training, membership dues, and new employee costs. The allocation of these costs consists of 25% of the costs from Economic Development and 100% of all the new employee's associated costs.
- The indirect costs are based on the Indirect model, excluding the Town Administrator costs. The
  indirect cost allocation expenses are comprised of the 2022 actual costs. These expenses are
  then allocated across the organization. The budgets of general legal, IT, Finance, HR, City Clerk,
  planning, space, and utility costs are used in the indirect methodology.
- Development Incentives: \$986,770 or 11% of the total budget. These are several different agreements the Town has made with various developers and shared revenue with the Lafayette. Also, in this category, is \$100,000 that finances the Downtown Revitalization Grant program.
- Capital Improvements: \$6,500,000 or 75.3% of the total budget. This is a combination of the "Land Acquisition, Ped Bridge, and Streetscape" details.
- Balance of Costs: Banking, County, and Bond costs comprise \$208,134, essentially, 2.5% of the total budgeted costs.
