Project Background

- 2019 Sustainability Plan
 - Committed to updating every 5 years
- 2023 completed 2021 GHG Inventory
- Home Rule Charter Commission: 23-01
 - "We recognize that Erie's history, character, and resources require a government that is dedicated to local control, sustainability, and the preservation of our natural environment".
- 2024 completed 2023 GHG Inventory
- 2024 Comprehensive Plan adoption
 - Committed to Climate Action Plan and updating Sustainability Plan

N1 Plan for a sustainable future.

N.1.1 ESTABLISH A CLIMATE ACTION PLAN FOR THE TOWN.

Working with Town staff and supporting organizations, create a Climate Action Plan based on the Green House Gas inventories that are collected and updated every two years.



N.1.2 REVIEW AND UPDATE THE SUSTAINABILITY PLAN FOR THE TOWN.

Update the Sustainability Plan every five years to ensure goals and policies reflect the community's desires and address current environmental issues. Work with the development community to educate and increase sustainable development measures and building design..




ERIE'S SUSTAINABILITY VISION




Climate Impacts in Colorado

- Draft plan available for feedback
- Present plan to Council in Nov/Dec 2025
 - Council adoption late 2025
- Implementation 2026-2031
