I was unable to attend the meeting discussing this proposal, and I realize that this has already been approved. I have heard some of your plans from neighbors, and I'm hoping that my comments may still be considered.

I live on Moffat Street. The increase in traffic, noise, and people over the last 3 years has been difficult to adjust to. Cars and trucks already speed on this road without any noticeable deterrence by law enforcement. If you encourage even more traffic into the heart of downtown, an even greater muddle will arise. And providing "easier access" to the schools at the west end of Moffat by routing the traffic through downtown is sheer absurdity.

It is my opinion that, at this time, the downtown Entertainment District is not large enough to accommodate all of the people you are trying to draw.

I would like to see:

- * a Moffat Street extension/bridge for pedestrians/bikes only
- * a change of Moffat Street to one-way, eliminating the need to widen it
- * parking lots for cars well outside of the Entertainment District to encourage foot traffic and bikes
- * more bike parking accommodations downtown
