## Town of Erie Ordinance No. 042-2024

## An Ordinance of the Town Council of the Town of Erie Updating the Town's Water Service Charges and Storm Drainage Fees

Whereas, to cover the costs of certain services, the Town charges fees;

**Whereas,** the Town has undertaken a Rate Study (the "2024 Rate Study") to analyze its Water Service Charges and Storm Drainage Fee; and

**Whereas,** the Town Council finds and determines that it is in the best interest of the Town to update the Town's Water Service Charges and Storm Drainage Fee in accordance with the 2024 Rate Study.

## Now Therefore be it Ordained by the Town Council of the Town of Erie, Colorado, as follows:

**Section 1**. The Town's Water Service Charges and Storm Drainage Fees allowed by Section 8-1-18 of the Erie Municipal Code are hereby updated as follows:

**Section 2**. The updated Water Service Charges and Storm Drainage Fees shall be reflected in the Town's Fee Schedule adopted by resolution pursuant to Section 2-10-1 of the Erie Municipal Code.

**Section 3**. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Town Council hereby declares that it would have passed this Ordinance and each part or parts hereof irrespective of the fact that any one, or part, or parts be declared unconstitutional or invalid.

**Section 4**. Safety. The Town Council finds that the adoption of this Ordinance is necessary for the protection of the public health, safety and welfare.

<u>Section 5</u>. <u>Effective Date</u>. This Ordinance shall take effect 10 days after publication following adoption.
