Pursuant to Article 8.03 of the Erie Home Rule Charter, the Municipal Judge shall be appointed by Town Council.

STAFF RECOMMENDATION:

Following presentations by candidates and questions from Councilmembers, adjourn to executive session regarding Municipal Judge contract negotiations.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

On July 9, 2024 Municipal Judge Teresa Ablao announced she would not be seeking re-appointment at the conclusion of her current term in April 2025.

The Town initiated a Request for Proposals (RFP) process and received twelve submissions. Proposals were reviewed by an internal Municipal Judge selection team, consisting of Court Administrator Danielle Trujillo, Director of Administrative Services & Operations Amy Teetzel, Deputy Town Manager Melissa Wiley, Deputy Town Manager Patrick Hammer, Deputy Town Clerk Kelsey Thede, and Police Chief Lee Mathis. Four applicants were invited to complete interviews with the Municipal Judge selection team on Jan. 22, 2025. The selection team recommends three candidates move forward with presentations before Town Council.

Candidates have been asked to prepare a 5 to 10 minute presentation for Town Council that includes details of their professional experience and qualifications for the position, their judicial philosophy, and how this appointment will align with their current schedule and workload. Following each presentation, there will be 15-minutes for questions from Councilmembers. Town Council will then adjourn to executive session.

RE:	PROPOSAL FOR TOWN OF ERIE MUNICIPAL JUDGE

Thank you for taking the time to review this proposal. I was very pleased to see the request for proposals regarding the municipal judge position, especially given that it is for the Town of Erie. I am certain I will be an excellent fit for Erie, its residents, and the Town's council and staff.

I am currently an associate relief judge for the City of Thornton. As a longtime dedicated public servant, I pursued this position to serve the public in a different way and to determine if I wanted to pursue further opportunities in a municipal judge role, beyond that of a relief position. It did not take me long to confirm that being a municipal judge is one of the most rewarding positions I have held over the course of my career. Once I made this determination, I set out to best position myself to be able to serve as a municipal judge to specific communities. I was overjoyed to learn that your Town posted the request, as I believe I would be a great match.

My proposal is supported by the culmination of my last 16+ years of legal work and public service experience. Over these years, I have served as a deputy district attorney, deputy city attorney, and most recently a municipal judge. Each of these experiences have provided me with the tools, technical skills, and judgment to serve the people and Town of Erie.

I started my legal career as a deputy district attorney for the First Judicial District Attorney's Office of Colorado (Jefferson County), where I was tasked to uphold the federal and state constitutions, follow the law, and to treat individuals with dignity, respect and compassion. Over the course of my service at the First Judicial District, I handled county court misdemeanors, juvenile cases, all levels of felony crimes, and led the office's intake department. I served as a trainer for the office, was a member of the statewide training committee, personally provided 30+ CLE trainings to prosecutors in Colorado and across the nation, and wrote the jury selection chapter for the National District Attorneys Association's Trial Advocacy Manual.

When assigned to county court, I developed the important skills of being able to speak with unrepresented persons in a way they understood. I also learned to manage a very heavy caseload efficiently, while still giving each case the attention justice required. These skills have translated well to my time on the Thornton bench. While the dockets in Thornton can be very heavily set, I am able to efficiently navigate them in a way that secures justice and leaves defendants and other stakeholders happy with the time and attention they received.

My work with juvenile defendants at the district attorney's office was very rewarding for the same reason I enjoy handling such cases as a judge today. Simply put, there is no opportunity to provide for real positive change more than by being involved in juvenile or lowerlevel adult offender cases.

Handling some of the most violent and complex felony-level cases in district court, including sex assaults and cold case homicides, provided me with something that is valuable and necessary for any judge: perspective. I am convinced that while state district courts do the most to keep violent offenders off the streets, it is municipal courts that do the most to keep individuals from becoming violent offenders in the first place. This understanding has provided me with the ability to make more fair, just, and valuable decisions on cases that appear before me.

My assignment to work in and lead the DA office's intake department was yet another experience that informed my judicial decision-making. The intake department at a DA's office makes decisions on what, if any, felony counts should be filed in the jurisdiction. In that role, I made critical and thoughtful decisions based on sound legal analysis. In addition, I was a resource for every police office throughout Jefferson County for questions about the law – how to interpret it, how it is to be applied, etc. This position provided further opportunity to finetune the skill of making the right decision.

My role as a deputy city attorney, where I managed the civil division of the City of Arvada's City Attorney's Office involved me managing five senior assistant city attorneys. Arvada is a city that is a Denver metropolitan city that wishes to simultaneously keep the identity and benefits of a small town. My experience in Arvada helped me become a better judge as well.

First, litigating and defending cases and disputes as counsel for the City and its employees provided me with the firsthand understanding of what it means to develop a valuable attorney-client relationship, and to provide clients with sound legal advice, counsel and risk analysis. This experience helped me gain insight into the positions of defense counsel and defendants appearing in municipal court.

Second, my responsibilities in this position helped me better understand local government's role in making a community a better place. Over the nearly five years I worked for Arvada, I was heavily involved with city leadership, council executive sessions and legislative drafting. I gained a clearer perspective on what municipalities do, who they serve, the issues they face, and the solutions they seek. A had the insight to understand how a municipality's judge is a vital position for the entire community. I am very familiar with community outreach efforts, as

well as alternative methods to address issues that municipal defendants often experience, and I am excited to provide my service to the Town of Erie.

For the last 12 years, I have been an adjunct professor at the University of Denver Sturm College of Law, where I teach students courtroom trial practice, including criminal procedure, as well as the rules of evidence. I have also routinely provided law enforcement academy instruction at the Colorado State Patrol and Red Rocks Community College Law Enforcement Academy.

Most recently, in December 2024, I decided to start a parttime solo practice for the direct purpose of creating the time and flexibility I need to pursue my passion to serve as a municipal judge.

I am a more well-rounded judge today because of the opportunities and experiences I have had to date. I hope to have the opportunity to further discuss why I am so excited about the prospects of this specific position. I do not have, nor do I anticipate having any conflicts of interest with the Town or its cases.

Cost Proposal.

- A. \$2,400 / month for the general court sessions held the second and third Monday of each month.
- B. \$150 / hour for additional court sessions, including any trials, hearings, and/or licensing authority matters, which may occur on the third Tuesday of each month.
- C. There may be necessary non-courtroom work that requires completion outside of the second Monday, third Monday, or third Tuesday of each month. I will perform the first two hours of such work every month without charge. I would charge \$150 / hour for any additional work beyond the two hours each month.

Existing Workload.

- A. I am an associate relief judge in Thornton. I will not accept work in Thornton for any of the Erie days. Additionally, I communicate with the Erie staff so that they are fully aware of what days (1 or 2 a month) that I would be serving in Thornton.
- B. I teach one class a week on Tuesday evenings at the University of Denver Sturm College of Law. This will not conflict with my responsibilities in Erie. However, I can switch the class to a different evening moving forward if the Council would prefer.
- C. I have started my own parttime law practice. This will not conflict with my responsibilities in Erie. I started the law practice so that I can take an opportunity like the one offered here.

Dear Mayor Moore and Members of Town Council,

I am privileged to submit my application for the position of Municipal Judge and Local Licensing Authority for the Town of Erie. For the last 5 years I have proudly served as municipal judge for the cities of Lafayette, Northglenn and Federal Heights. Prior to that I was honored to serve in the public sector as a public defender for 13 years, during that time I became a wife, a Lafayette homeowner, and a mother to two lively and loving little boys. Both of my boys play baseball with Coal Creek Little League, which serves the Erie and Lafayette communities. After having lived in Lafayette since 2007, Erie has become a place where I've formed relationships and built meaningful ties, making it feel like an extension of my own neighborhood. I feel a strong connection to Erie, and my familiarity with the area allows me to bring a unique perspective and commitment to the Municipal Court.

I believe Municipal Courts are more than a place where people are prosecuted. The focus of the Courts where I serve is on improving the lives of those who appear, while fostering compliance with the law and ensuring safe and secure neighborhoods. I have extensive experience working with a diverse cross section of local communities ranging from my time working with the Big Brother/Big Sister Program in Washington DC to representing extremely mentally ill clients who have been hospitalized in Colorado. As a woman of Chinese and Hispanic descent I am familiar with the challenges faced by many litigants. My cultural competencies have assisted me in communicating with those that appear before me in Court, as well as working with my former clients and community members who come from different ethnic, educational and socioeconomic backgrounds. Through representing thousands of clients, I know how a person feels when they first enter the criminal justice system.

All of these experiences have enhanced my patience, compassion and open-mindedness. I understand the impact that the legal system has on all parties involved with a case. The Erie Municipal Court is a place where the judge has the opportunity to take care of its community and have a true impact on those who live, work or spend time in the Town.

In November, I submitted by resignation to the City of Northglenn, as I was looking to spend more time with my family. However, when I learned that Judge Teresa Ablao decided to retire, I was excited at the prospect of being able to serve the Town of Erie, my extended community, as the Municipal Judge. My schedules in Lafayette and Federal Heights do not conflict with Erie's needs and will still allow me to spend more time with my family. The Request for Proposals for the Town of Erie Municipal Judge stated that interested applicants must provide their cost proposal, including detail on billing structure and rates.
