AN ORDINANCE OF THE TOWN OF ERIE, COLORADO, AMENDING TITLE 2, "FINANCE AND REVENUE," CHAPTER 10, "FEE SCHEDULE," SECTION 2-10-3 "POLICE DEPARTMENT FEES" OF THE MUNICIPAL CODE OF THE TOWN OF ERIE, COLORADO; SETTING FORTH DETAILS IN RELATION THERETO;

WHEREAS, the Board of Trustees of the Town of Erie believes it is in the best interest of Erie to amend the Code as set forth herein, and that such action is necessary for the immediate preservation of the public property, peace, health, safety, and welfare of the Town and for the financial well being of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF ERIE, COLORADO, AS FOLLOWS:

Section 1. Title 2, "Finance and Revenue," Chapter 10, "Fee Schedule," Section 2-10-3, "Police Department Fees," of the Municipal Code of the Town of Erie, Colorado is hereby repealed and re-enacted to read as follows:

<u>Section 2</u>. Severance Clause. If an article, section, paragraph, sentence, clause or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Board of Trustees of the Town of Erie, Colorado hereby declares that it would have passed this Ordinance and each part or parts thereof, irrespective of the fact that any one part or parts may be declared invalid or unconstitutional.

Section 3. Repeal. All other ordinances or parts of any ordinances or other Code provisions in conflict herewith are hereby repealed.

Section 4. Effective Date. This ordinance shall take effect thirty (30) days after publication following final passage.
