

## **Project Description:**

The Flatiron Meadows Filing No. 8 Final Plat creates 17 single family lots, 6 tracts and associated right-of-ways on 151.026 acres.

The Community Development Director and Public Works Director have conditionally approved the Flatiron Meadows Filing No. 8 Final Plat, contingent upon the acceptance of the dedications and development agreement by the Board of Trustees and the filing of appropriate documents with Town staff.
