Chairman Farr opened the Public Hearing at 6:04 p.m. Mrs. Bachelder presented the background, application and staff recommendation of approval, and entered the documents into evidence for the Orchard Glen Filing 1 Home Owners Association request to replace the existing perimeter fencing at the same height with the same materials.

Public Comment was taken from Tom Swihort, 2149 Chestnut Circle; David Strejc, 2119 Chestnut Circle; Kendra Ficek, 2203 Chestnut Circle; and Phillip Neitenbach, 2227 Chestnut Circle. All testified to their loss of privacy (their properties all back to Erie Parkway) since the road was raised three feet and the sidewalk was put in last year. They testified people walking on the sidewalk can look right over the existing 6 foot fence into their backyards and homes. They pled for higher fencing or some other remedy to their loss of privacy and also asked if a different fence material such as vinyl could be used. Cheryl Bonham, 746 Pope Drive, Vice President of the HOA advised the Board that this was the first she knew about the problem with the sidewalk, so that had not been taken into consideration.

Board questions concerned whether or not they could delay a decision and would the fence go to the Planning Commission after the Board of Adjustment ruling.

Chairman Farr closed the Public Hearing at 6:24 p.m.

The Board requested and received direction from staff.

Mr. Horovitz moved to refer the Orchard Glen application back to staff for continued discussions with the home owners associations. The motion, seconded by Mr. Bowker, carried with all voting in favor thereof.

STAFF REPORTS & DISCUSSION ITEMS

Chairman Farr noted the open seat on the Board of Adjustment and urged anyone interested to fill out an application on the town web site. Mr. Ostholthoff noted the Board of Trustees will be making appointments to the various Boards and Commissions serving the Town on May 10th.
