Hannah Hippely, Senior Planner presented the Sketch Plan for Erie Highlands Planning Areas 8 and 9. The site is located at the corner of Erie Parkway and County Road 5 and equates to approximately 40 acres of land. Planning Area 8 has 104 proposed units; resulting in 4.4 units per acre. Planning Area 9 is a higher density area with 9.2 units per acre.

A PUD Amendment for this development would be required in order to address the orientation and dimensional requirements of the Unified Development Code (UDC).

Ms. Hippely stated that staff is looking for feedback from the Commission on the development pattern. In addition, staff is recommending that some guest parking be incorporated in this development proposal.

John Glaser, Oakwood Homes, introduced himself and thanked the Commission for being available to review the Sketch Plan and staff for their hard work up to this point. Oakwood Homes is excited to introduce a product that will add variety to the community and reach multiple buyer profiles. John introduced Layla, of Terracina Design, to provide more detailed information on their proposed product.

Layla Rosales, Terracina Design, provided further detailed information on the carriage house product; who buys it and why; and how this product will be an asset and benefit the town.

Bruce Rau, Vice President of Land Development of Oakwood Homes, stated they've enjoyed working in our community and are really excited to bring this new product to Erie. The product allows for different lifestyle and pricing choices; more attainable housing with high quality, low maintenance living.

The Commission had an opportunity for questions and discussion regarding the proposed Sketch Plan.
