1. The undersigned Bidder proposes and agrees, if this Bid is accepted, to enter into an Agreement with the Town in the form included in the Contract Documents to perform and furnish all Work as specified or indicated in the Contract Documents for the Contract Price and within the Contract Time indicated in this Bid and in accordance with the other terms and conditions of the Contract Documents.
2. Bidder accepts all of the terms and conditions of the Invitation to Bid and Instructions to Bidders, including without limitation those dealing with the disposition of Bid Security. This Bid will remain subject to acceptance for sixty days after the day of Bid opening. Bidder represents and acknowledges that it has read the Agreement included in the Contract Documents, is willing to sign said Agreement in the form it is presented therein without modification, and will sign and submit said Agreement with the Bonds and other documents required by the Bidding Requirements within ten days after the date of the Town's Notice of Award. Bidder further agrees to complete all work covered by the Bid, in accordance with all applicable requirements. Bonds are not required for Contract amounts under \$50,000 unless indicated differently in this Invitation to Bid or the Contract Documents.
3. In submitting this Bid, Bidder represents, as more fully set forth in the Agreement, that:
 - (a) Bidder has examined copies of all the Bidding Documents and of the following Addenda receipt of all which is hereby acknowledged: (List Addenda by Addendum Number and Date):

- (b) Bidder has familiarized itself with the nature and extent of the Contract Documents, the Work, site, locality, and all local conditions, and laws and regulations that in any manner may affect cost, progress, performance or furnishing of the Work.
 - (c) Bidder has studied carefully all reports and drawings of subsurface conditions and drawings of physical conditions which are identified in the General Conditions, and accepts the determination set forth in said General Conditions. Bidder has inspected the site and has obtained, conducted and carefully studied (or assumes responsibility for obtaining and carefully studying) all examinations, investigations, explorations, tests and studies which pertain to the subsurface or physical conditions at the site or otherwise may affect the cost, progress, performance or furnishing of the Work as Bidder considers necessary for the performance or furnishing of the Work at the Contract Price, within the Contract Time, and in accordance with the other terms and conditions of the Contract Documents, including specifically the General Conditions; and no additional

examinations, investigations, explorations, tests, reports or similar information or data are or will be required by Bidder for such purpose.

- (d) Bidder has reviewed and checked all information and data shown or indicated on the Contract Documents with respect to existing Underground Facilities at or contiguous to the site and assumes responsibility for the accurate location of said Underground Facilities. No additional examinations, investigations, explorations, tests, reports or similar information or data in respect of said Underground Facilities are or will be required by Bidder in order to perform and furnish the Work at the Contract Price, within the Contract Time and in accordance with the other terms and conditions of Contract Documents, including specifically the General Conditions.
 - (e) Bidder has correlated the results of all such observations, examinations, investigations, explorations, tests, reports and studies with the terms and conditions of the Contract Documents.
 - (f) Bidder has given Project Manager written notice of all conflicts, errors, ambiguities or discrepancies that Bidder has discovered in the Contract Documents and the written resolution thereof by Project Manager is acceptable to Bidder, and the Contract Documents are generally sufficient to indicate and convey understanding of all terms and conditions for performing and furnishing the Work for which this Bid is submitted.
 - (g) This Bid is genuine and not made in the interest of or on behalf of any undisclosed person, firm or corporation and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation; Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid; Bidder has not solicited or induced any person, firm or corporation to refrain from bidding; and Bidder has not sought by collusion to obtain for Bidder any advantage over any other Bidder or over the Town.
 - (h) Bidder has not allowed any competing bidder or employee or agent thereof to see its Bid or to know of its contents; has not discussed the contents of its Bid with any competing bidder, or any other person who a reasonably prudent person would believe would be likely to transmit information to a competing bidder; and has drafted its Bid independently of any competing bidder.
 - (i) Bidder is qualified to do business in Colorado.
 - (j) Bidder understands that the Town reserves the right to reject any and all bids.

1.0 Demolition \$ 30,000⁰⁰ LS

This item shall include all demolition tasks for completion and site preparation for new construction. This may include perimeter sidewalk/trail and curb/gutter replacement as necessary.

2.0 Site Work \$ 510,000⁰⁰ LS

This item shall include all earthwork, grading, drainage, erosion control, storm drainage utilities, parking lot, concrete walks, curb/gutters, curb ramps, playground curbs and hardscape, and include all other materials and labor required to complete items not specifically described or included in other bid items. * see below

3.0 Park Shelter \$ 34,000⁰⁰ LS

This item shall include provision and installation of park shelter, shop drawings, footings and include all other materials and labor required for installation.

4.0 Site Furnishings \$ 31,000⁰⁰ LS

This item shall include provision and installation of all park benches, trash receptacles, charcoal grill, bike racks, shop drawings, footings, and include all other materials and labor required for installation.

5.0 Play Equipment \$ 147,000⁰⁰ LS

This item shall include provision and installation of all play, climbing and exercise equipment, shop drawings, footings, and include all materials and labor required to complete items not specifically described or included in other bid items.

6.0 Fall Surface \$ 100,000⁰⁰ LS

This item shall include provision and installation of EWF and PIP rubber fall surfacing (to approach depths), shop drawings, and include all other materials and labor required for installation.

7.0 Irrigation System \$ 132,000⁰⁰ LS

This item shall include provision and installation of a complete irrigation system, all parts, equipment and controls, materials and labor required as required.

8.0 Landscape \$ 190,000⁰⁰ LS

This item shall include all trees, shrubs, ornamental grasses, perennials, sod, seeding soil preparation, edger, rock mulch, crusher fines paving, dry stream bed, all materials and labor as




