If your business is located in a metropolitan Colorado county (Larimer, Weld, Boulder, Adams, Jefferson, Broomfield, Denver, Arapahoe, Douglas, El Paso or Pueblo) your interest rate will be fixed at 8.75%. If your business is located in any other Colorado county, your interest rate will be fixed at the Wall Street Journal Prime Rate + 2.00%.
