#### 1) 2021 COMMUNITY SURVEY - TWO QUESTIONS IN REGARDS TO A POTENTIAL MARIJUANA POLICY

- To what extent would you support or oppose ending Erie's current moratorium on retail marijuana businesses and instead establish strict zoning guidelines and regulations to permit Recreational and Medicinal Cannabis retail stores in specified locations within the Town of Erie?
- If Cannabis retail stores were permitted within the Town of Erie, to what extent would you support or oppose the adoption of an additional local excise tax on the sale of cannabis products similar to those taxes currently imposed in neighboring communities? (e.g., Boulder, Lafayette, Louisville - 5% excise tax, Longmont - 3% excise tax).

#### 2) WHAT STATUTORY TOWNS ARE BRINGING IN REVENUE FROM MARIJUANA SALES FROM EXCISE TAX?

#### • Vic researched CO municipalities that permit the sale of marijuana

- 167 statutory jurisdictions in CO
  - 126 do not permit marijuana sales / 41 allow retail sales
- 103 Home Rule jurisdictions in CO
  - 50 do not permit marijuana sales / 53 allow retail sales
- Most municipalities that do permit the sale of marijuana apply a 5% excise tax

#### 3) PLANNING DEP. – BEST PRACTICES

- <u>Allowed Zone District</u>: CC-Community Commercial
- <u>Separation of Uses</u>: 1,000 feet from any school and child care centers. 250 feet from residentially zoned property.
- Separation of Medical/Retail Marijuana Stores:
  - No medical/retail marijuana store shall locate closer than 1,500 feet from another medical/retail marijuana store.
  - Potentially limit total number of stores to 3 to 6 for the whole Town. Limiting the number and limiting the market could monopolize the license.
- <u>Maximum Size of Facility</u>: 3,000 sf for a single use (medical or a retail) /5,000 square feet for a combined medical and retail marijuana store.
- Odor Reduction Requirements: Ventilation required. The odor of marijuana shall not be perceptible to an ordinary person at the exterior of the building or space adjoining the licensed premises.
- <u>Security Measures</u>: These should be reviewed by the Police Department. Planning and Economic Development support the inclusion of security measures.

#### 4) HIGH-LEVEL BREAKDOWN OF THE \$22 PER CAPITA NET REVENUE

• Candice provided a spreadsheet with her methodology to derive the \$22 per capita net revenue. The city names are not listed to comply with State law regarding confidentiality of sales tax information (some locals have so few vendors it would be possible to identify individual establishment's sales).

#### 5) STATE VS LOCAL AUTHORITY – WHAT AUTHORITY DOES THE TOWN HAVE TO REGULATE THE POTENCY, QUANTITY SOLD, ETC.?

- Municipalities may restrict:
  - Distance between premises for which local licenses are issued
  - Reasonable restrictions on the size of an applicant's licensed premises
  - Other requirements necessary to ensure the control of the premises and the ease of enforcement of the terms and conditions of the license.
  - The local requirements can be more restrictive than state requirements
  - Depending on the Ordinance, it may be possible to establish limits on serving size
- Potency is regulated at a state level

#### 5) STATE VS LOCAL AUTHORITY...CONTINUED

- Per State mandatory rules:
  - A new license may not be issued for a medical marijuana dispensary within 1,000 of a location where another application was denied within the past two years
  - Applicant must have existing lease/ownership of property and the zoning must permit the activity
  - Additional distance requirements surrounding schools, alcohol or drug treatment facilities, child care facilities, and higher education institutions. (See slide 24)
  - Minimum age to purchase -18 years for medical and 21 years for retail.
  - Medical marijuana unless otherwise prescribed, there is a limit of 2 ounces or 6 immature plants
  - Retail marijuana 1 ounce limit, but this excludes nonedible, non-psychoactive retail marijuana products such as topical ointments and lotions.
  - Restrictions on marijuana advertisements that specifically target underage individuals

#### 6) MORE DETAIL ON HOW DELIVERY WORKS. WHO RECEIVES THE TAX REVENUE?

- Marijuana delivery permits are separate from a general license to operate as either a medical or retail dispensary
- If a marijuana dispensary delivers a product to an address in the Town, the sales tax is paid to the Town.
- A dispensary must charge a \$1.00 delivery fee that is remitted to the municipality where the licensed medical marijuana store is located
- Retail marijuana is subject to both a 15% sales and excise tax, and local governments receive 10% of the15% retail marijuana sales tax.

#### 7) LIQUOR VS MARIJUANA HISTORICAL INCIDENCES IN ERIE

- Note 1: The first four columns of data (MJ Juvenile Arrests, MJ Adult Arrests, Alcohol Juvenile Arrests and Alcohol Adult Arrests) are all driving-related charges to which include DUID, DUI and DWAI.
- Note 2: The second four columns of data (MJ Juvenile Citations, MJ Adult Citations, Alcohol Juvenile Citations and Alcohol Adult Citations) are for possession, consumption, in public or providing to minors citations. No arrests were made with these cases.

# 8) WHAT WOULD THE COMMUNITY ENGAGEMENT PLAN LOOK LIKE TO EDUCATE RESIDENTS?

- The State of CO has educational materials on the topic of retail marijuana. The Communications Department will tailor these materials to Erie's needs.
- Post educational material and encourage two-way questions, comments, and feedback in typical channels:
  - Facebook, Twitter, Instagram, Nextdoor, etc.
  - EngageErie
  - Potential for in-person discussions as needed/appropriate
- Will partner with important partners in health and safety including public health departments, law enforcement, and youth leaders.

#### 9) EFFECTS ON PUBLIC HEALTH

- Minimal change of high school students using marijuana from 2013-2019 (21% vs 24%)
- Potency of products in the main concern at an education, safety and health standpoint – dabbed
- Delivery Considerations:
  - Driver safety (use while delivering), ID verification, daily limits difficult to track, normalization of marijuana use (perceived as the least harmful substance by youth)

#### BACKGROUND

- Amendment 64 passed in 2012. At that time, BoT chose not to permit the sale of marijuana products in Erie.
- In 2016 Town formed a Retail Marijuana Ad-Hoc Committee to review whether the permanent ban on the sale of marijuana products in Erie should be lifted. In 2017, the BoT voted to continue the ban.
- With many changes in the cannabis industry, and use in Erie by individuals, the BoT requested Town staff reexamine this issue in 2021.




### U.S. Cannabis Laws

Recreational marijuana states


Medical marijuana states

Marijuana prohibition states




#### CURRENT MAP OF LEGALIZED MARIJUANA USE BY STATE

#### NEARBY COMMUNITY COMPARISONS – ACTIVITY & TAX RATE

- Allowed activities: Sales, cultivation, manufacturing and testing
  - Boulder (33) 5% excise tax, 3.5% sales tax
  - Lafayette (3)- Sales and excise tax 5%; up to 10%
- Allowed activities: Sales, cultivation and testing
  - Louisville (4) 5% excise tax on cultivation
- Delivery only (no sales tax)
  - Superior
- Testing only.
  - Broomfield 5% excise tax
- Sales only
  - Longmont (4) 3.5% sales tax; 3% excise tax with authority up to 15%

#### PROS & CONS EVALUATION CRITERIA

#### POTENTIAL TAX REVENUE FOR ERIE

- Based on data from 17 CO cities on total revenue from all cannabis related sources (including State shared revenue<sup>1</sup>), and expenses associated with administration and enforcement, the average net revenue per capita for CO cities is about \$22.00/Capita.
- Based on that figure, a city of 30,000 could reasonably expect to see net revenue of \$660,000 annually.
- Based on other factors and alternative approaches to estimating potential revenue and expenses, Town staff estimates net revenue for Erie could range from \$250,000 to \$500,000 annually.

(1) State redistributes 10% of total revenue received from its 15% Excise Tax on marijuana. The State has two 15% tax impositions; only one is shared with the cities that sell marijuana.

#### STEPS TO LEGALIZE

Board decides on strategy to move forward Draft ordinance, licensing fee and schedule (with input from Town staff and BOTs)

Board adopts licensing and permit process Introduce measure to residents for vote (if Town wants to tax the use –recommended)

#### STATE SETBACKS OR LOCATIONAL RESTRICTIONS

- CRS 44-10-311(1)(d)(l) a medical marijuana dispensary cannot be located within 1,000 feet of "school; an alcohol or drug treatment facility; the principal campus of a college, university, or seminary; or a residential child care facility"
  - Option for local government to waive requirements
- MED 3-735 Regulated Marijuana Business cannot advertise on any outdoor sign that is within 500 feet of an elementary or secondary schools, places of worship, or public playgrounds
- Ultimately, the Town decides the location for both medical and retail marijuana businesses, with one minor caveat for advertising.

#### THINGS TO CONSIDER TO ADOPT AN ORDINANCE PERMITTING THE SALE OF MARIJUANA

- Operated similarly to liquor license with Municipal Judge as Hearing Officer.
- Identify zone, odor, distance, and other restrictions
  - We can be as restrictive/flexible with ordinances (sexually oriented businesses)
  - 2015 International Building Code (Town adopted) marijuana retail establishment = Group M Occupancy (Mercantile)
- Drafting ordinance
  - Drafted from Marijuana code title 44, or a nearby "successful" municipality (Thornton)
  - Residential vote to tax > Ballot in Nov. 21 or wait until April 22

#### CHIEF STEWART'S RESEARCH

- Information was gleaned from four (4) law enforcement departments.
- If the direction is to move forward, the Erie Police Department will ensure we are ready for what the future may hold in terms of dispensaries.

#### **CITY OF LONGMONT**

- Longmont has 4 dispensaries; 3 are recreational and 1 is medical/recreational.
- Longmont does not have many enforcement issues or concerns related to dispensaries possibly because they provide training to the dispensary employees similar to liquor enforcement training.
- 2 officers oversee the dispensaries. The State has a marijuana enforcement office in Longmont and this office provides the majority of oversite for the dispensaries.
- The City of Longmont has very strict rules and regulations with the establishments. Longmont has thus far had good luck working with the owners and they seem willing to correct issues right away.

#### CITY OF LAFAYETTE

- Lafayette has 3 dispensaries which are each medical/recreational.
- They do not have many enforcement issues or concerns. At the inception of the dispensaries, they had an armed robbery and a few compliance issues.
- Their Detective Section is assigned the task of enforcement.
- Not much time is spent on enforcement on a regular basis. Up front, Detectives conduct backgrounds which take some time.
- The only thing Lafayette PD would have liked to have changed was the process for licensing with the City. Backgrounds seemed to take a priority over their case load.

### **CITY OF LOUISVILLE**

- Louisville has 4 dispensaries which are all medical/recreational.
- They have had a couple of burglaries which were pretty significant.
- Their largest issue is public consumption in parking lots or nearby hotels. When the movie theater was open, they had even more issues with public consumption.
- No specific officer is assigned as a marijuana officer.
- Other than extra patrols or responding to a calls, they do not spend much time at the dispensaries.
- Location is very important for Louisville. Optimally, dispensaries should be near a highway or in a business district vs. putting one near a neighborhood or school.

#### **CITY OF THORNTON**

- Thornton has 3 dispensaries which are all medical/recreational.
- Ownership and transfer of ownership to employees require necessary backgrounds and fingerprinting. Managers are required to be fingerprinted once a year for regulating purposes.
- They have only had one burglary. They conduct compliance checks to ensure the dispensaries are following regulations.
- 1 Detective is assigned as the marijuana officer; this detective is also assigned to process registered sex offenders and provide liquor enforcement checks.
- 40% of the Detective's time is spent working compliance and regulatory issues with the dispensaries.

- Loveland approximately 77,000 population

- Firestone approximately 20,000 population
- Frederick approximately 13,000 population

#### CITY OF LAKEWOOD

• "better to control your own destiny"

- Council did not take action and a community ballot was brought to a vote via a cannabis lobbyist.
  - Limits permits to existing medicinal retailers
  - Does not tax beyond normal sales tax
  - Ordinance not written by your "standard professionals" has created many difficult nuances



It is unclear if this means the 57% want the 1000' distance to be greater or if they do not want such a location at all. (See Ref 1)

The question (Ref 2) related to the separation between stores/facilities is similar in nature. No specific conclusion can be derived from the results. It does, <u>however, support the opposition (60% +)</u> identified for <u>Businessess.</u>

The questions related to specific locations (Ref 3s) identified opposition to each mentioned location in Erie. These results appear consistent with the initial discussion of the Marijuana Committee as to potential acceptable location(s). This initial discussion focused on the commercial area along I-25 which is away from future residents, schools and other such facilities would achieve protected separation requirements.

Compared to the Amendment 64 Results (45% "NO") – 2015 Survey Results Are **More Negative With Respect to Establishing Stores in Erie** (60%+ Against)
