• Big goal for 2020 was pesticide usage. It is getting a lot of traction. Goal to get ahead with pesticide use. Currently there are organizations against use of Roundup and 24D (?). They are very effective. Mike has reached out to several manufacturers to find alternatives. Mike has a list of alternatives and will be doing trials on them. Meeting with Louisville Open Space team to find out what they're doing. Talking with Boulder as well. Mike's team is gathering data and talking with chemical manufacturers to find solutions.

• What does SAB think about pesticide use? SAB master plan has a goal to reduce chemical use. SAB could help spread the word and educate the community about pesticide use.
