**Action:** Judge Ablao opened the Public Hearing at 1:05 p.m. on the application submitted by Brandon Grasmick, Recreation Coordinator and Levi Moser, Recreation Supervisor for Town of Erie regarding Tails & Ales. Attorney Kristin Brown represented the Town of Erie. Brandon talked about the alcohol control plan, TIPS training, food trucks, and mentioned the event has been successful in the previous years without any concerns. Ms. Brown concurred with Brandon that the event does run smoothly and had no objections.

**Action:** Judge Ablao, the licensee meets the reasonable requirements of the Town and the requirements of State law, and based upon these findings, Judge Ablao approved the special event permits for Town of Erie. This hearing closed at 1:09 p.m.

**Action:** Judge Ablao opened the Public Hearing at 1:09 p.m. on the application submitted by Jonathon Mares and Perla Ruiz, co-owners of The Dug Out Grill and Bar. Attorney Kristin Brown represented the Town of Erie. Jonathon and Perla spoke about adding approximately 1000 sq. feet to the existing location. Currently, they are on a month to month lease. Judge Ablao continued the hearing to a later date to research further the lease requirements.

No one from the public was there to speak for or against the application.


