**STAFF RECOMMENDATION:**

Adopt Resolution approving said purchase, authorize the appropriate Town officer to execute said purchase, and authorize staff to spend funds.

**SUMMARY AND BACKGROUND OF SUBJECT MATTER:**

As part of its 2021 work plan, the Board expressed a desire to accelerate the timeline for the completion of the Coal Creek Park redevelopment project and later appropriated funds to start construction in fall of 2021. Staff have been working with the design team and vendors to finalize pricing for the project, including major items such as equipment for the splash pad.

Staff was recently informed by our splash pad vendor that beginning in October equipment costs are projected to increase by 5.5% due to escalation in raw material, manufacturing, and shipping costs. These increases could result in the Town paying an additional \$14,000 to \$15,000 to procure the equipment at a later date. By purchasing the equipment now, the Town locks in the current lower price and triggers the manufacturing and production process. Delivery timelines for play equipment are now anticipated between eight to 10 months. It is to the Town's advantage to secure equipment sooner rather than later given the volatile pricing and extended production timelines.
