**STAFF RECOMMENDATION:**

Approve Resolution on the URA Revitalization Incentive Grant Agreement for Chiropractic Center of Erie.

**SUMMARY AND BACKGROUND OF SUBJECT MATTER:**

On October 27<sup>th</sup>, 2020 the Board of Trustees approved the Revitalization Incentive Grant Program. In November 2020 the Economic Development Department began accepting applications with an enrollment window deadline of December 4<sup>th</sup>, 2020. We received eight applications. On December 10<sup>th</sup>, 2020 the Grant Review Committee comprised of representatives of the Downtown Erie Business Association, the Erie Chamber and the Erie Economic Development Council selected two applications (Chiropractic Center of Erie and ComVet), which they recommend for approval.

The Chiropractic Center of Erie applied to the business siting and expansion program for their project

located at 698 Briggs Street (application attached). Their application indicates this reimbursement grant will help enable the applicant to add an additional 5 jobs and activate two additional levels of currently unused office space in Downtown Erie. This grant represents approximately ten percent of the total project costs (\$519,000).

Staff recommends approving this reimbursement grant for the amount of \$51,900 to Chiropractic Center of Erie for the construction that is to be done at 698 Briggs St. This will use approximately half of the \$100,000 the Board allocated for incentive grants in the 2021 budget.
