### **SUMMARY AND BACKGROUND OF SUBJECT MATTER:**

**Requested Action:** Acceptance of the Annexation Petition for the Stanley property and the setting of a public hearing for said annexation.

The approving resolution does two things:

1. Establishes that the Board of Trustees finds the Annexation Petition to be in substantial compliance with the laws of the State of Colorado.

2. Sets a Public Hearing date and time of January 23, 2018, at 6:30 p.m., in the Erie Town Hall, 645 Holbrook, Erie, CO 80516.

**Purpose:** The Stanley annexation petition requests annexation to the Town of Erie of an approximate 0.316 acre parcel.

**Location:** This site is located along Erie Parkway, and Erie Parkway and North 11<sup>th</sup> Street and is generally described as a portion of Section 22, Township 1 North, Range 69 West of the 6<sup>th</sup> Principle Meridian.

**Existing Zoning:** 'A' - Agricultural (Boulder County)

**Size:** Approximately 0.316 acres
