Construction Contract

An invitation to bid was released on May 9, 2018 and five companies requested a bid packet. Due to the high demand of poured-in-place contractors and only one materials supplier in the Colorado service area only one bid was received. The bid received was from Star Playgrounds, formerly known as Children's Playstructures and Recreation, a company the Town used for the playground resurfacing projects at the Ballpark at Erie and Longs Peak Playground. Past projects completed by this contractor have been completed satisfactorily and staff is confident in their work and level of service.
