Approve the Resolution to award said contract, authorize the appropriate Town officer to execute said contract, and authorize Staff to expend contracted funds.

SUMMARY AND BACKGROUND OF SUBJECT MATTER:

According to the Centers for Disease Control and Prevention (CDC), [West Nile virus](https://www.cdc.gov/westnile/index.html) (<<https://www.cdc.gov/westnile/index.html>> (WNV) is the leading cause of mosquito-borne disease in the continental United States. It is most commonly spread to people by the bite of an infected mosquito. Cases of WNV occur during mosquito season, which starts in the summer and continues through fall. There are no vaccines to prevent or medications to treat WNV in people. Fortunately, most people infected with WNV do not feel sick. About 1 in 5 people who are infected develop a fever and other symptoms. About 1 out of 150 infected people develop a serious, sometimes fatal, illness. You can reduce your risk of WNV by using insect repellent and wearing long-sleeved shirts and long pants to prevent mosquito bites.

To minimize the chances of contracting WNV in Erie, the Town budgets for and contracts for mosquito control services. Staff requested competing bids for this service, however, the only bid received for this specialized service was from Vector Disease Control International, LLC. Staff recommends awarding the contract to Vector Disease Control International, LLC. because Vector Disease Control International, LLC has previously completed this service for the Town of Erie and the price is similar to past years. The proposed contract allows for a renewal option for up to two consecutive years following the initial award (a total of three years). A renewal occurs when both the Town and Contractor/Vendor agree, the increased price is no more than 2% of the previous year and performed work was satisfactory.
