


NEIGHBORHOOD MEETING NOTICE

The 10.4 acre tract is currently undeveloped. The site will consist of a mix of light industrial and hangar buildings, with principal access off Airport Drive. The proposed Minor Subdivision and Planned Unit Development (PUD) Rezoning submittals were approved by the Town in the Spring of 2023. The Applicant has recently constructed a similar development directly to the east of the subject property.


