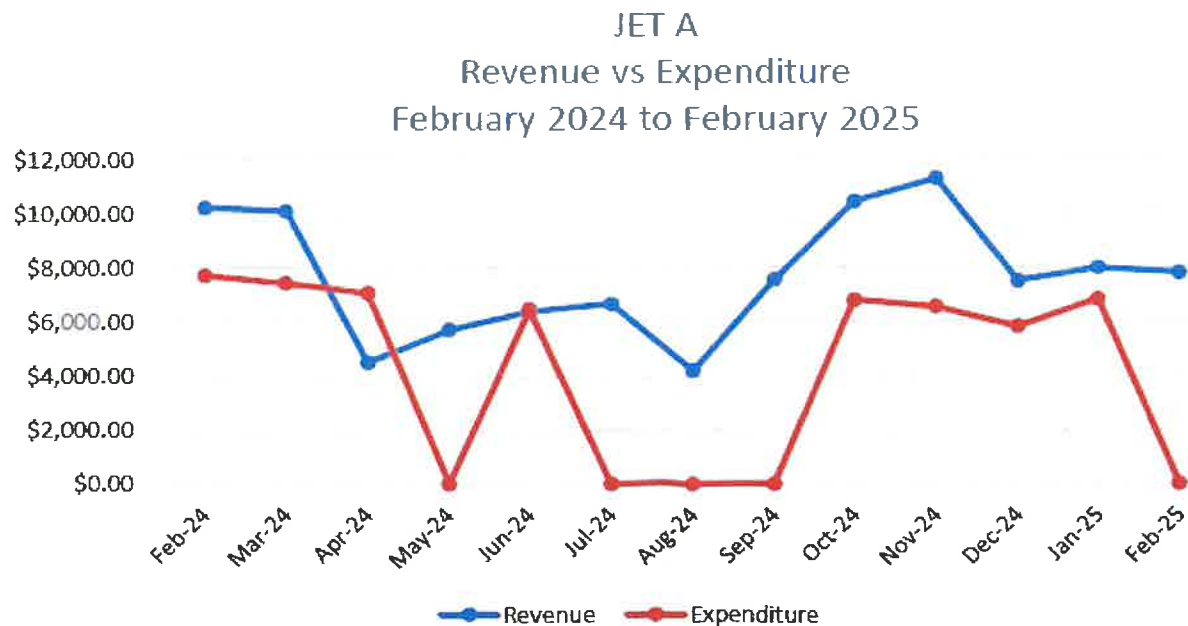
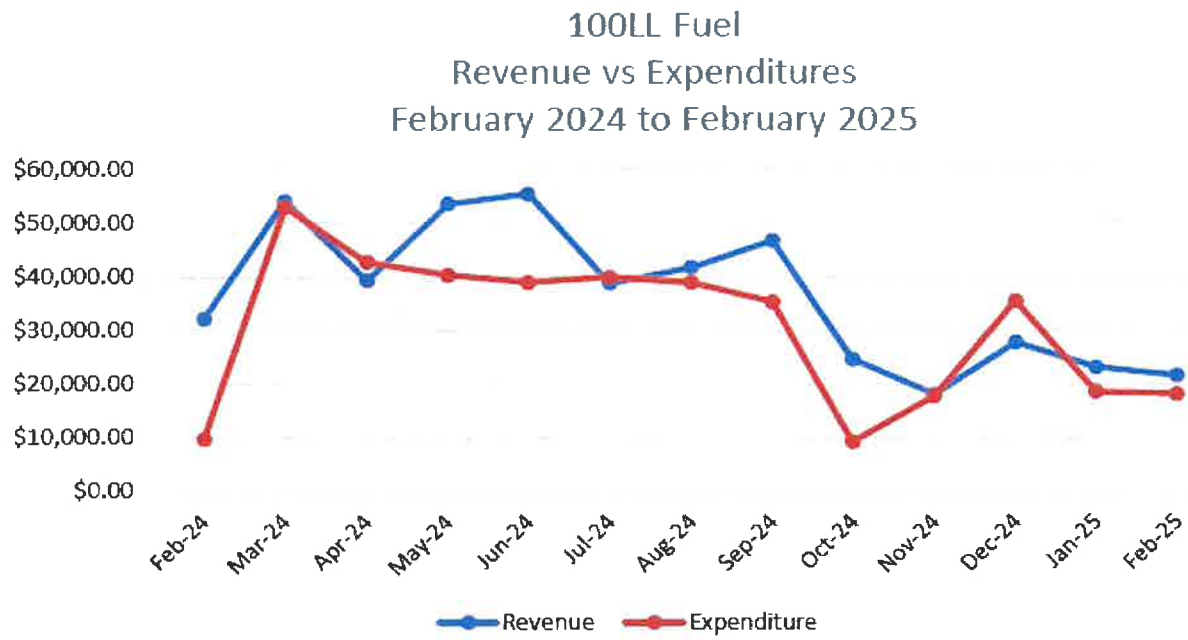

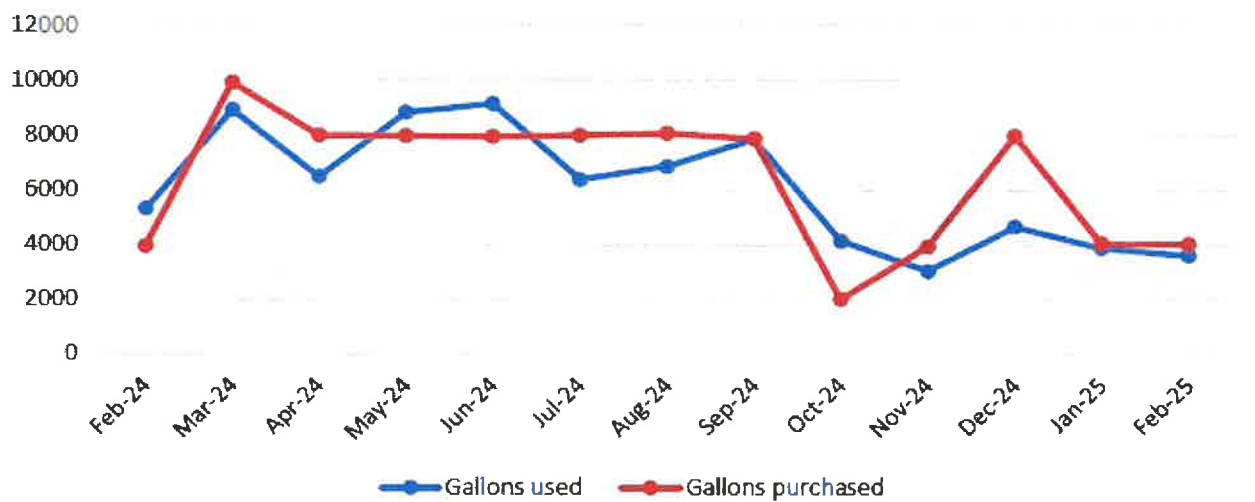
100LL and JETA FUEL - REVENUE VERSUS EXPENSES - FEBRUARY 2024 TO FEBRUARY 2025
