

**Second Amendment to Agreement for Professional Services
(Construction Management Services for Weld County Road 3 Bridge
Replacement Improvements P22-076CM)**

This Second Amendment to Agreement for Professional Services (the "Second Amendment") is made and entered into this ____ day of _____, 2025 (the "Effective Date"), by and between the Town of Erie, a Colorado home rule municipality with an address of 645 Holbrook Street, P.O. Box 750, Erie, CO 80516 (the "Town"), and Ulteig Operations, LLC, an independent contractor with a principal place of business at 3350, 38th Avenue South, Fargo, ND 58104 ("Contractor") (each a "Party" and collectively the "Parties").

Whereas, on November 12, 2024, the Parties entered into an Agreement for Professional Services (the "Agreement"); and

Whereas, on July 7, 2025, the Parties amended the Agreement to add additional services and change the amount of compensation (the "First Amendment"); and

Whereas, the Parties wish to amend the Agreement again as set forth herein.

Now Therefore, for the consideration hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Amendments. The Agreement is hereby amended as follows:

a. Scope of Work. Exhibit A to the Agreement is hereby amended by the inclusion of the additional items set forth in Exhibit A-1, attached hereto and incorporated herein by this reference.

b. Compensation. Exhibit B to the Agreement is hereby amended to increase the maximum amount of compensation to \$222,812 allocated as follows

Original Contract Amount:	\$178,500
1st Amendment:	\$ 22,312
2nd Amendment:	<u>\$ 22,000</u>
Total New Contract Amount	\$222,812

c. Term and Termination. The schedule completion for these services is extended to November 3, 2025.

2. Remainder of Agreement. Except as expressly modified herein, the Agreement as modified by the First Amendment shall remain in full force and effect.

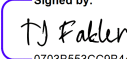

Contractor Duties:

During the term of this Agreement, Contractor shall provide the following additional project management, construction inspection and documentation services related to corrective construction of the concrete bridge abutments and asphalt roadway pavement; and schedule extension to November 3, 2025, as directed by the Town.
