Town of Erie Ordinance No. 003-2025

An Ordinance of the Town Council of the Town of Erie Correcting Clerical Errors in Ordinance 039-2024, Regarding Water Tap Fees

Whereas, on December 10, 2024, the Town Council adopted Ordinance 039-2024, An Ordinance of the Town Council of the Town of Erie Updating the Town's New Water Tap Fees, Fees in Lieu of Water Dedication and Wastewater Tap Fees;

Whereas, Ordinance 039-2024 contained two clerical errors, one regarding the 2024 amounts of potable water tap fees for taps from one inch to six inches in size, and the other regarding water tap fee amounts for small homes; and

Whereas, the Town Council finds and determines that it is in the best interest of the Town to correct the clerical errors in Ordinance 039-2024.

Now Therefore be it Ordained by the Town Council of the Town of Erie, Colorado, as follows:

Section 1. Section 2 of Ordinance 039-2024 is amended to replace the "Potable Water Tap Fee" portion of the fee chart for 2024 with the following:

Section 3. Except as expressly amended herein, Ordinance 039-2024 shall remain as originally adopted.

Section 4. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Town Council hereby declares that it would have passed this Ordinance and each part or parts hereof irrespective of the fact that any one, or part, or parts be declared unconstitutional or invalid.

Section 5. Safety. The Town Council finds that the adoption of this Ordinance is necessary for the protection of the public health, safety and welfare.

Section 6. Effective Date. This Ordinance shall take effect 10 days after publication following adoption.
